ARTICLE 35

To see if the Town will vote to authorize the Town Tax Collector to enter into a standard agreement with taxpayers establishing a **TAX CLUB** payment plan for property taxes on their primary and legal residence, whereby: (1) the taxpayer agrees to pay specified monthly payments to the Town based on his/her tax obligation for the current years property taxes; (2) the Town agrees not to charge interest on timely payments made pursuant to the tax club agreement; (3) the agreement is automatically terminated if the taxpayer misses two scheduled payments, the taxpayer then becomes subject to the same due dates and interest dates and rates as other taxpayers who are not participating in a tax club (4) only taxpayers who do not have any

outstanding tax obligations for prior tax years are eligible to participate in the tax club program; and (5) taxpayers wishing to participate in a tax club for a particular property tax year shall enter into an agreement with the Town.

ARTICLE 39

To see if the Town will vote to approve the Municipal Officers’ Order of Discontinuance of an unused portion of the **Canton Mountain Road** without reservation of a public easement in the same, dated February 11, 2019 and filed with the Town Clerk. Also to see if the Town, pursuant to 23 M.R.S.A. § 3025, will vote to accept the dedication of a certain parcel of land at 156 Canton Mountain Road for a Town Way for Highway Purposes from J. Thomas Boldway Trustee, being more particularly bounded and described in an Easement Deed from J. Thomas Boldway Trustee to the Town of Jay and to authorize the Selectpersons to accept on behalf of the Town a deed from the landowner under such terms and conditions as are in the best interest of the Town. (This article serves to discontinue an old, unused portion of Canton Mountain Road and accept the existing, relocated portion of the Road)

To see if the Town, pursuant to 30-A M.R.S.A. § 5403, will vote to:

- Accept a **sewer easement** from Thomas Cerulli located on a piece of property described in Book 2554, Page 308 recorded in the Franklin County Registry of Deeds, located adjacent to Route 4 and further identified as tax map 9 Lot 31 and to authorize the Select Board to accept on behalf of the Town such easement upon such terms and conditions that are in the best interest of the Town;
- Accept a **sewer easement** from Raymond L. Fleury, II located on a piece of property described in Book 1950, Page 134 recorded in the Franklin County Registry of Deeds, located adjacent to Route 4 and further identified as tax map 10 Lot 2 and to authorize the

Select Board to accept on behalf of the Town such easement upon such terms and conditions that are in the best interest of the Town;

- Authorize the Select Board to negotiate with the Department of Agriculture, Conservation and Forestry, Bureau of Parks and Lands for the **sewer lease** of a certain parcel of land being approximately 2.5 miles on the Whistle Stop Multi Use Rail Trail, more particularly described in the Book 1889, Page 173 recorded in the Franklin County Registry of Deeds, and to authorize the Select Board to accept on behalf of the Town such lease upon such terms and conditions that are in the best interest of the Town?
