June 10, 2024 SELECTBOARD MINUTES

1. Pledge of Allegiance – 6:00 Tim led the pledge.

2. Public Hearings on Liquor Licenses:

Special Taste Testing Event for Eco Fest & River Clean-Up Celebration – Public hearing held. Event to take place from 11:00 a.m. to 4:00 p.m. M/M/S Lee Ann/Tom to approve the liquor license for the Special Taste Testing event. Vote 5-0-0

Backwoods Eatery – Public hearing held. It was noted that the property is 1/3 mile from the nearest church. This was corrected on the application. M/M/S Lee Ann/Tom to approve a liquor license for Backwoods Eatery. Vote 5-0-0.

3. Minutes – May 28, 2024 – M/M/S Tim/Tom to approve the minutes from the May 28, 2024 Selectboard meeting. Vote 5-0-0.

4. Old Business - No discussion.

5. Begin Road Stream Crossing Reconstruction Project Bids – The town received 3 bids. J. Pratt Construction, Inc. bid \$365,763.00. C.H. Stevenson, Inc. bid \$374,575.00. Bedard Excavation bid #385,000.00. M/M/S Lee Ann/Tom to award the Begin Road Stream Crossing Reconstruction Project to J. Pratt Construction, Inc. for \$365,763.00 Vote 5-0-0

6. Hutchinson Road Ridley Brook Crossing Reconstruction Project Bid – The town received 3 bids. Starrett Snow & Landscape Services bid \$310,000.00. J. Pratt Construction, Inc. bid \$375,135.00. Bedard Excavation bid \$675,000.00 M/M/S Tim/Tom to award the Hutchinson Road Ridley Brook Crossing Reconstruction Project to Starrett Snow & Landscaping Services for \$310,000.00. Vote 5-0-0

7. Public Works Sand and Salt Building Repair Bids – The town received 1 bid from Thomas C. Goding Construction for \$43,700. M/M/S Lee Ann/Tom to award the Public Works Sand and Salt Building Repair project to Thomas C. Goding Construction for \$43,700. Vote 3-1-1 Gary opposed. Tom abstained.

8. Ultraviolet Cured-In-Place Sewer Pipe Bids – The town received 2 bids. Vortex Services, LLC bid \$39,840.00 plus \$7,500 for each 10" diameter pipe point repair and \$12,500 for each protruding service connection. National Water Main Cleaning Co. bid \$106,758.75 plus \$4,500 for each 10" diameter pipe point repair and \$100.00 for each protruding service connection. M/M/S Gary/Tom to award the Ultraviolet Cured-In-Place Sewer Pipe project to Vortex Services, LLC. Vote 5-0-0

9. North Jay Fire Station Concrete Apron Bids & Paving – The town received 3 bids. Grimaldi Concrete Floors bid \$17,560.00. Another bid from Grimaldi Concrete Floors was \$18,511.00. Thomas C. Goding Building Constructors bid \$12,955.00. M/M/S Lee Ann/Tim to award the North Jay Fire Station Concrete Apron project to Thomas C. Goding Building Constructors. Vote 3-1-1. Gary opposed. Tom abstained.

The paving at the North Jay fire station was already discussed at a previous meeting. An alternative to digging up the pavement, redoing the base and repaving is proposed. This would be a 1.5 inch surface layer over the existing pavement and walkway. This would cost approximately \$15,000 versus the original cost of \$32,000. M/M/S Gary/Tom to have Pike's do a 1.5 inch surface layer over the existing pavement and walkway at the North Jay fire station for an estimated \$15,000. Vote 5-0-0

10. Dixfield – Police Services Proposal Request – Gary made a motion to move forward with the proposal. There was no second to the motion. Motion died. M/M/S Tom/Lee Ann to not pursue a proposal for Dixfield to provide them with police services. Vote 5-0-0

11. Central Maine Cost Recovery Contract Revision- CMCR is increasing their percentage of recovered costs. There was some confusion on whether it will be going to 35% temporarily and then back down to 20% or if it will be at 25% permanently going forward. The \$25 per claim minimum is being eliminated. Regardless of which it is, Chief Booker recommended staying with the program. Through June 30, 2023 CMCR recovered \$8,503 for the town and in the current fiscal year they have collected \$4,654. M/M/S Lee Ann/Tom to accept the revised contract with Central Maine Cost Recovery pending clarification of the changes. Vote 5-0-0

12. Other Business – Legislative Policy Committee – Gary would like to continue to serve on this committee. Lee Ann/Tom to nominate Gary for the Legislative Policy Committee. Vote 5-0-0.

Terry announced upcoming dates of interest.

13. Executive Session – MRS Title 1, Ch. 13, Sect. 405 ss 6.A. Personnel – Compensation - M/M/S Tim/Tom to go into Executive Session under MRS Title 1, Ch. 13, Sect. 405 ss 6.A. Personnel – Compensation. Terry declared the Board out of Executive Session. M/M/S Lee Ann/Tom to allow the Town Manager to carry over any remaining earned time into the coming fiscal year. Vote 5-0-0
